Use of Corporate Cards and purchase orders for procurement as preferred option as opposed to General Purpose Expenditure Vouchers.

Future Service Delivery Model

A presentation on the QFES service determination and delivery model to deliver better outcomes for the community.

Contract Management Capability

A governance process enabling better visibility of contracts and ensuring contracts are managed and monitored effectively and efficiently.

Standing Offer Arrangement Contract Owner Roles and Responsibilities

A presentation on contract owner roles and responsibilities around procurement.

Workplace Conduct Branch

A QFES Workforce Conduct Strategy was presented which gives QFES the opportunity to pre-empt and proactively prevent matters escalating to disciplinary outcomes.

To ensure communication and engagement activities align with community, government and QFES expectations, a Release of Information Policy, delegations matrix, and media and social media standards and procedures have been developed, along with supporting information to guide personnel releasing information.

Stakeholder Engagement Strategy

ELT discussed QFES' commitment to stakeholder engagement.

<u>Disaster Management - Queensland Natural Hazards Risk Framework</u>

A presentation on the Queensland State Natural Hazard Risk Assessment was provided to ELT. QFES' comprehensive and vigorous methodology of applying risk which directly improves linkages between LDMG and DDMG risk assessments, planning, operations and State risk priorities.
