To assist with the implementation of a Fire Safety Management Plan (FSMP), use the following checklist to ensure the components of the FSMP have been included. The tick boxes will assist in determining if all requirements have been met.

Is the Fire Safety Management Plan readily accessible, located on the premises, regularly updated, and presented in an acceptable format?

Does the Fire Safety Management Plan include: -

Information regarding the building?

Including:

- ☐ building name (if applicable)
- ☐ building address
- ☐ building owner's name, address, and contact details

A record of the maximum allowable number of occupants for each sleeping area of the building?

Including:

- ☐ bedroom, or sleeping area, measurements (length x breadth)
- ☐ floor area of each bedroom or sleeping area (m²), divided by 2.5m², to ascertain the maximum number of allowable occupants
- ☐ acknowledgment of a 900mm clear path of travel to the exits of the bedroom or sleeping area

A record of the building's prescribed fire safety installations?

Including:

- ☐ date of installation (if known)
- ☐ name of person, or company, who installed this equipment
- ☐ brand name
- ☐ model number or type of equipment (if applicable)
- ☐ mounting location of portable equipment (e.g., fire extinguishers)

A maintenance schedule for all prescribed fire safety installations within the building?

Including:

- ☐ a record of when each prescribed fire safety installation requires servicing, inspection, or maintenance

Including:

- ☐ provision for any occupants with disabilities
- ☐ actions required by staff (if applicable)
- ☐ procedures to be followed by residents, visitors, contractors, and any other people who may be in the building during an evacuation
- ☐ copy of the fire and evacuation sign that is posted throughout the building

A proposed training program for residents and staff for fire management and prevention, and emergency evacuation?
