## Marine Rescue Implementation Working Group Meeting - 24 June 2021

The Marine Rescue Implementation Working Group (MRIWG), which is advising QFES on the future of the integrated service, held its third meeting on 24 June 2021 in Brisbane. During this meeting the working group worked through several key areas to inform how the new single integrated service will be implemented.

Working group members were briefed on the Resource to Risk Assessment progress with face-to-face engagement underway with Coastguard Flotillas and Volunteer Marine Rescue Squadrons. This process will help guide the government's investment for the future capability needs of the sector, including vessel replacement. The group was also updated about the draft Concept of Operations and the steps in the policy process to 'create' the new service.

Members were developed priorities for the sub-working groups which will help shape the future service. The Fleet Sub-Working group was discussed and how that will deliver vessel replacement over the next few years. This is in line with the government's commitment to the new service and to address the sectors ageing fleet profile.

There was also a discussion about how existing QFES structures will support the future marine rescue service including alignment of rank and positions and recognition of honours and awards.

QFES Deputy Commissioner Mike Wassing reaffirmed the commitment of Government to deliver an integrated service outcome, which will best support volunteers and community safety and will gain pace with additional resourcing and enable the program team to engage more regularly with sector volunteers. The next MRIWG meeting is scheduled for 7 September 2021.

## **Resource to Risk Assessment Update**

The MRI team have continued the statewide rollout of the Resource to Risk Assessment with ongoing consultation with both AVCGA and VMRAQ executives. Queensland Police Service (QPS) and regional QFES staff have also attended these consultation sessions. The Resource to Risk Assessment process has provided the volunteers the opportunity to have their say on resourcing in their region and the state. The units who have participated so far have enjoyed the process with overwhelming positive support for the process. The MRI team have worked together with units to provide a greater understanding of the process and outcomes it will lead to. Our thanks go out to all volunteers and executives who have assisted us to date.

## New Marine Rescue Implementation (MRI) Team Members

All MRI positions are fully funded from the QFES budget for 2021-22 and will not impact the \$35m Government Commitment to the sector. To best support the development of the new integrated service, QFES has grown the MRI team with four team members now onboarded for a two-year period and they have hit the ground running. Two additional team members will join the MRI team from mid to late July 2021. QFES Assistant Commissioner Joanne Greenfield and MRI Director, Matthew Thompson will continue to lead the MRI program. Meet some of the new team members below.



#### Samantha Morrison, Senior Program Officer, (Risk and Capability)

Sam is overseeing the Resource to Risk Program, working closely with the VMR and Coastguard groups across Queensland to develop a clear picture of the risks facing marine rescue across the state. This will help inform the future service delivery model and concept of operations. Sam's background is in disaster management, filling multiple roles across state and local government and most recently was the Senior Emergency Management Officer with Ipswich City Council. Sam is no stranger to QFES having previously worked with the Emergency Management Planning Unit in the State Disaster Coordination Centre through multiple disaster events and was also briefly Staff Officer to the QFES Commissioner.

#### Elizabeth (Libbie) Robinson, Senior Business Analyst

Libbie will be undertaking a current state analysis of the systems used by the marine rescue services in Queensland to determine the business requirements for future systems to support volunteer, asset and incident management functions. Part of Libbie's role will be engaging relevant sector stakeholders from within QFES and partner agencies as well as AVCGA and VMRAQ to ensure all needs can be met by the future solution.

Prior to starting in the MRI team Libbie worked at QPS Policelink undertaking business analysis activities for the public facing web forms and underlying systems used by QPS staff.









#### Annette Curry, Senior Communications and Engagement Officer

Annette will be looking after communications and engagement and working directly with Coastguard and Volunteer Marine Rescue volunteers, along with QFES and other stakeholders. Previously Annette worked at the Cross River Rail Delivery Authority, Queensland Ambulance Service and not-for-profit organisations. Annette comes with broad experience across media, internal and external communications, stakeholder engagement and social media.

#### John Schwarzrock, Senior Program Officer (Fleet)

John will be working with volunteer marine rescue teams across the state to support the fleet and overall marine rescue asset management into the future. John worked the last 29 years with Queensland Parks and Wildlife Service, and the last 21 years involved in the Marine Park Management along the Queensland Coast. John is a Commercial Skipper, Marine Engineer Grade 1, Diesel Mechanic with a love of all things on and in the water.

## VMR's oldest active skipper steps down

VMR Bundaberg recently celebrated Bill Ker stepping down from the active skippers list. After being a rescue vessel commander for 23 years Bill decided the 2am phone activations were getting harder to deal with. Bill joined VMR Bundaberg in 1998 after a career in the navy where he had several roles including as a clearance diver. When he arrived in Bundaberg, he joined the radio room before joining the duty skipper list and was involved in 555 activations and had 1,618 hours of sea time. Bill became a Life Member in 2010. At 83, Bill is believed to be the oldest active skipper across the Queensland VMR Squadrons. He retired from active skipper duties in February but still continues to participate in other duties including manning the radio and mentoring the squadron. VMR President Erwin Hoffman presented Bill with his Meritorious Service Award and his duty shingle. Congratulations Bill and thank you for your service!

## AVCGA QF6 Mooloolaba rescue reunion

In April, QF6 Mooloolaba reunited with Maike and his 7-year-old son Julian Hohnen who were rescued in June 2019. The dramatic search began with an urgent boat sinking call at Caloundra 9 Mile with Maike, Julian and Maike's friend rescued after six hours in the water. Maike has stayed in touch with QF6 and wanted to meet the "Mooloolaba Rotary Rescue" crew who took part in the search and rescue. The crew showed Maike, Julian and puppy Daisy around the base and the boat. Maike told the QF6 crew that almost losing his life has changed his views on being prepared. He hopes his story serves as a cautionary tale for boaties to be prepared before they head out on the water having the right the equipment needed in case of emergency situations.

The training operation attracted plenty of local onlookers and enthusiasts. Joint collaborative exercises with other agencies and partners help marine rescue services prepare and improve responses to any response or emergency situations.

### Service Agreements Update

Renewing the Service Agreements for both AVCGA and VMRAQ is a high priority for QFES with new Service Agreements remaining under negotiation with both organisations. As flagged in the previous Communique, included in the Service Agreements will be the additional \$10,000 to be made available to each Volunteer Marine Rescue Squadron and Coast Guard Flotilla announced by the Minister on 29 April 2021.
