 - b. Active charges and warrants to arrest.
 - c. Information subject to name suppression where that information is necessary to the purpose of the vet.
- 2. If I am eligible under the Criminal Records (Clean Slate) Act 2004, my conviction history will not be released unless:
 - a. Section 19(3) of the Clean Slate Act applies to this request (exceptions to the clean slate regime).

- 3. Information provided in this consent form may be used to update New Zealand Police records.
- 4. I am entitled to a copy of the vetting report released to the offshore agency (to be provided by the offshore agency) and can request a correction of any personal information by contacting the Police Vetting Service.
