The Marine Rescue Implementation Program continues to move towards a single integrated marine rescue service - Marine Rescue Queensland. The project team has been out and about visiting units and meeting with volunteers as part of the Roadshow and providing program updates and undergoing logo consultation. I was pleased to join the team at the Cairns Roadshow and met with QF9 Cairns volunteers.

Thank you to the units who have hosted the project team and thank you to the volunteers who have attended the sessions. We certainly appreciate the time and effort in attending.

Logo consultation for Marine Rescue Queensland has been extended to 31 October 2022 and I encourage any volunteer who has not yet had the opportunity to have their say, to do so. The feedback is critical and helps inform the logo development.

The Marine Rescue Implementation Working Group met on the 18 October 2022 and an update will be provided in a Communique after the meeting.

Logo survey extended



Thank you to the 700 volunteers who have participated in the <u>Marine Rescue Queensland Logo</u> <u>Survey.</u>

The <u>survey</u> has been extended to **Monday**, **31 October 2022** and all volunteers are encouraged to get involved and have their say. The <u>survey</u> has three questions and only takes two minutes to complete.

There has been significant interest in the logos and it will shape the future identity of Marine Rescue Queensland. We encourage all marine rescue volunteers to share their views and contribute to the conversation and logo development in the concept stages.

The results of the survey will be reported to the Marine Rescue Implementation Working Group for progression. The outcomes will also be communicated to volunteers once work is complete.

Training support for volunteers and communities



More than \$400,000 funding has been provided to Volunteer Marine Rescue Queensland Association (VMRAQ) to build foundation marine qualifications through training for communities and volunteers in the Torres Strait and Gulf of Carpentaria.

The funding will support community members and future volunteers to receive their Recreational Marine Driver's Licence (RDML), providing support to existing and future demand on services.

Maritime Safety Queensland (MSQ) are assisting with the program, which will enhance training and capability in communities across the Torres Strait and Gulf of Carpentaria.

VMRAQ identified that there was limited access to obtaining marine qualifications in the Far Northern remote areas and this was impacting local communities. VMRAQ proactively worked with MSQ and QFES to develop a program and secure funding for the communities to grow capability locally.

Direct Unit Relief Grants

The 2022-23 Direct Unit Relief Grants are now closed and are being assessed, and those who applied will be advised the outcome of applications by 30 November 2022.

The Direct Relief Unit grants provided \$10,000 per marine rescue unit to directly support marine rescue services and emergency response capability which includes the replacement of necessary equipment or fund facility maintenance based on local needs.

Community Sustainability Action Grant



<u>Funding is available for community-led projects</u> for renewable energy and energy efficiency solutions for Queensland.

Grants up to \$100,000 (excluding GST) will be provided for eligible projects that give community organisations including marine rescue units to reduce emission, boost renewables and reduce energy use and costs that come with running facilities and services.

Marine rescue units will need to apply directly for the grants <u>here.</u> Applications close at 4pm, Wednesday 7 December 2022.
